THE SOCIAL SECURITY (SELF EMPLOYED PERSONS) (AMENDMENT)
REGULATIONS made in exercise of the powers contained in sections 19, 21, 26, and 47 of the
Social Security Act, Cap. 408.

1. Short title

These Regulations may be cited as the Social Security (Self Employed Persons) (Amendment)
Regulations, 2016.

2. Interpretation

In these Regulations, “principal Regulations” means the Social Security (Self Employed Persons)
Regulations 2013, S.I.No.17 of 2013.

3. Amendment of Regulation 4

The principal Regulations is amended in regulation 4 by repealing paragraph (a) and substituting
the following—

“sixteen years of age and over and has not attained the pensionable age nor has received or is
in receipt of pension benefit;”.

4. Amendment of Regulation 10

The principal Regulations are amended in regulation 10 sub regulation (3) by repealing the word
“charge” and substituting the word “change”.

5. Amendment of Regulation 15

The principal Regulations are amended in regulation 15 sub regulation (1) by repealing the word
“unemployment” in paragraph (c) and substituting the word “employment”.

6. Amendment of Regulation 18

The principal Regulations are amended in regulation 18 by repealing the words “until he in no
longer” and substituting the words “until he is no longer”.

7. Amendment of Schedule

The principal Regulations are amended by repealing the Schedule and substituting the following—
